2. Said parking right shall not be assigned without permission of LaSalle Court Parking and Park and Shop.

Thank you for your interest in the LaSalle Court Parking Ramp. One of the benefits of being a contract parker is that your parking pass card will grant you access to the LaSalle Court Parking Ramp and the Park and Shop, which is located across the street next to the Macy's Department Store. It is our goal to be the safest, cleanest, most user-friendly parking facilities in town. Below please find a brief description of the LaSalle Court Parking Ramp:

1. The LaSalle Court Parking Ramp is open 24 hours a day. We never close.
2. The elevators have been modernized and are state of the art.
3. The parking ramp has two entrance lanes and four exit lanes. Your parking pass card can be used at any of these six lanes.
4. If you should enter the facility without using your pass card, your pass card will not work at the exit. When exiting the ramp, simply present your parking ticket and pass card to the attendant.
5. If your pass card is unavailable, see the Ramp Manager to have your parking ticket validated, or pay for the day's parking fee and submit the cash register receipt to the Ramp Office for reimbursement.
6. All major credit cards are accepted for payment. Recurring charges and one time only charges for parking fees are available. We also accept Automated Clearing House (ACH) transactions. ACH is a paperless system that allows for payment of your monthly parking charges directly from your checking or savings accounts.
7. Escort service is available upon request.
8. Emergency alarm buttons are located through out the parking ramp and stairways.
9. Closed circuit television cameras with audio alarms are located in the elevators, lobbies, stairway, and vehicle entrance and exits.
10. Ramp employees are patrolling the premises and are in radio contact with a uniformed security guard.
11. LaSalle Court is skyway connected to Macy's and LaSalle Plaza.

12. There is direct access from the ground level to Eighth Street, LaSalle Avenue and the Nicollet Mall.

14. Your parking space is guaranteed at both of our locations! When the “Ramp Full” sign is displayed, there will be a dedicated “Contract Only” lane at the entrance of the LaSalle Court Parking Ramp. The PARK AND SHOP WILL HAVE A DEDICATED VEHICLE ENTRANCE OFF HENNEPIN AVENUE for Contract Parkers only. Your pass card will raise the gate even when the full sign is on, and there will be a parking space waiting for you.
